Festival Hours: Saturday 10:00 AM till 5:00 PM. Please be prepared to be open for business during the entire listed times.

Set-Up and Tear-Down

*Check-in will begin on Saturday at 7:00am. Someone will come to your car and give you your booth number.

*Vendors must provide a 10x10 tent to display items.

*Vendor's vehicles are to be removed from the festival grounds by 9am Saturday. You will be given a designated area to park.

*After the posted start time of the festival, no vendor vehicles will be allowed to drive in the area.

*Electricity is not provided; gas generators are allowed by vendors.

Craft Items:

* Please **Only** handmade crafts, individual artworks, and published authors are allowed.

* No sound amplification: "Gregory Farms Fall Festival" includes live entertainment performed on the stage.

* Vendors are not allowed to "entertain" by singing, playing instruments or any type of sound amplification from any booth space.

* Once you send in pictures of your craft you will be notified of approval.

Please send this application prior to September 1, 2024. Fees are waived for Non Profit. Please inquire about a space for your charity. Again, vendor selection for "Gregory Farms Fall Festival" is entirely up to the discretion of Gregory Farms and Vineyard Staff.

*We do not rent spaces to any commercial businesses. We do not allow consignment spaces or tables, computer generated items nor political pieces.

***** Requirement for all Vendors*****

All vendors must check in prior to setting up. Someone will come to your vehicle to check you in and give you your space number. If you do not check-in, we could possibly assume you are a “no show” and assign your space to someone else. Also, if you do not check-in and happen to set up in the wrong spot, you will have to relocate.

To All Vendors: You will be directed to the vendor parking area.
